MEETING DATE: October 22, 2024

MEETING PLACE: City Hall, 101 W. Main Street, Madison, IN 47250

The Common Council of the City of Madison, Indiana met in regular session at 5:30 P.M. at City Hall, 101 W. Main Street, Madison, IN 47250.

Mayor Bob Courtney opened the meeting with the Lord's Prayer followed by the Pledge of Allegiance to the Flag.

Present: Wilber, Bartlett, Schafer, Krebs, Thevenow, and Dattilo were present. Storm was absent (6-0).

Minutes: Wilber moved to approve the October 7, 2024, seconded by Schafer. All in favor, motion carried (6-0).

Presentation of petitions, memorials, remonstrances, introduction of motion & guests: Swearing-In of MPD Officer Austin Ames: MPD Chief Shawn Scudder: Austin Ames took the oath as the newest MPD patrolman recruit. Austin was previously a patrolman with the West Lafayette Police Department.

Bills on second reading: Ordinance 2024-13: Amending Section 93.22 of the Housing Discrimination Ordinance: *Defines the role of HRC for community outreach and alignment with Indiana Civil Rights Commission responsibility.* **Motion:** Bartlett moved to waive the rules and move to third reading, seconded by Wilber. All in favor, motion carried (6-0).
