MEETING DATE: Tuesday, November 19, 2024, at 5:30 PM

The Common Council of the City of Madison, Indiana met in regular session at 5:30 P.M. at City Hall, 101 W. Main Street, Madison, IN 47250.

Mayor Bob Courtney opened the meeting with the Lord's Prayer followed by the Pledge of Allegiance to the Flag.

Present: Wilber, Schafer, Krebs, Bartlett, Storm, and Dattilo were present. Thevenow was absent from the meeting (6-1).

Minutes: Wilber moved to approve the November 6, 2024, seconded by Krebs. All in favor, motion carried (6-0).

Presentation of petitions, memorials, remonstrances, introduction of motion & guests: Jon Menke Award Presentation – Mayor Bob Courtney: The City of Madison honored Colonel Norbert Anthony "Tony" Steinhardt Jr. with the 2024 Jon Menke Award for Military Service. Recognized for his 34 years of distinguished service in the U.S. Army and Indiana National Guard, including his heroic leadership during the 1974 Madison tornado disaster, Tony exemplifies dedication to his country and community. His military achievements, including serving in Operation Desert Storm and receiving the Legion of Merit, reflect the selflessness and sacrifice the award commemorates.

Thevenow): Implements the capital funding strategies for road improvements as adopted in the 2025 budget. Authorizes up to \$1,750,000.00 bond repaid over ten years at an interest rate not to exceed 6%. Roll Call Vote: Krebs – Y, Dattilo – Y, Schafer – Y, Storm – Y, Bartlett – Y, and Wilber – Y. All in favor, ordinance passes (6-0).
